

# FROM THE EXECUTIVE DIRECTOR



Dear Friends and Allies,

In spite of the many obstacles facing our environment and our communities in 2017 -- from the rolling back of important environmental protections to natural disasters and political gridlock -- the environment and conservation movement came together like never before. I saw everyone from international groups to local all-volunteer groups participating in activities and actions across the country to protect clean water and the living things that rely on it.

### Alabama's river movement was no exception.

The Alabama Rivers Alliance grew our outreach & partnership activities exponentially throughout the year. Each action taken was a strategic move toward protecting clean water and our 132,000 miles of rivers & streams.

Through our **partnership** with the Southern Environmental Law Center, we were able to commission public opinion polling which revealed that 4 in 5 Alabamians want an Alabama Water Plan.

As a supporter of ARA, you know that our years-long fight for this plan is important and we must continue to push for it in this election year until a plan is in place to protect stream flows & provide equitable solutions in times of water shortage.

By **collaborating** with Alabama's eight Waterkeeper organizations, the Alabama Department of Environmental Management and sewer utilities, we have made progress towards improving the way the public is notified of sewage spills in their community and this vital information has been made more accessible to people across the state.

By **partnering** with Sierra Club Alabama Chapter, Conservation Alabama, and the national Sierra Club, we educated citizens on the legislative process and provided extensive training on how to talk to elected officials about their concerns for clean water and a protected environment.

By **collaborating** with American Rivers, River Network, the Cahaba River Society and other local partners, we are continuing the critical work to find solutions for protecting natural stream flows and vital fish habitat through existing regulations.

The list of successes in 2017 through our strategic **partnerships** and collaborations goes on and on and you will see many of them highlighted throughout this report. As an Alliance, having a strong network of watershed and community based partners is the key to success in advocating for Alabama's rivers. We value these organizations and individuals who make our organization possible and who are willing to collaborate beyond their local watershed or community to solve statewide threats to clean water and public health.

As we look back at a successful 2017 and our 20-year history, we are even more excited about the next 20 years. Thanks to your support this year, we were able to add 440 new members, grow our email list by 136%, and increase our reach on Facebook (15%), Twitter (24%) and Instagram (34%). It is only with this strong foundation that we are able to create a hopeful vision for the future and take on new initiatives like the inspiring and engaging Southern Exposure Film Fellowship program.

# ALABAMA WATER PLAN UPDATE

The Alabama Rivers Alliance continued our full court press to lead the grassroots advocacy for an Alabama Water Plan in 2017. While politics and state leaders were not as cooperative as we hoped, important policy initiatives continued throughout the year and we are still progressing in the right directions.

#### Some of our successes this past year include:

- Engaged hundreds of citizens to write letters to Governor Ivey asking that the Alabama Water Agencies Working Group report be released to the public (report contains recommendations for the development of a plan).
- Kept this issue alive through the change in leadership in the Governor's office via social media, letter writing campaigns, media articles and op-eds and more.
- Worked with American Rivers to get the entire Mobile Basin designated as one of America's Top Ten Most Endangered Rivers due to lack of a statewide water plan.
- Introduced a strong bill from Representative Patricia Todd to address gaps in water laws that are hindering the ability to develop a plan protecting stream flows and accounting for water use.

- Worked alongside SELC to commission polling and messaging around this issue that will be used in the coming election year and legislative session (see graphic).
- Garnered significant media attention throughout the year, even during the Senate special election in December.
- Agencies released the Surface Water Assessments and Groundwater Assessments that were completed with funding from the general fund over the past few years. The lack of data regarding water consumption and availability has been a hindrance in developing a plan.

# SUPPORTING LOCAL PARTNERS

As the Alliance Coordinator, I traveled the state talking to partners from all of Alabama's watersheds and meeting with concerned citizens from all four corners of our state. This past year was an exciting one for our efforts to support and strengthen local groups in order to have a strong Alliance protecting clean water and healthy rivers across Alabama. By my last count, I met with 33 groups across Alabama and participated in 36 different partner organizations' events to listen, learn, support and spread the word about the importance of working together for clean water.





In January, we hosted a screening of the Wild & Scenic Film Festival at Straight to Ale Brewing. The event brought in more than 200 attendees and proceeds were shared with three organizations in the Tennessee Watershed.

In March, we hosted our annual Alabama Water Rally at Camp McDowell on Clear Creek in the Black Warrior Watershed, where we celebrated our 20th anniversary as an organization. The event had record attendance, boasting

a 70% increase from the previous year. Harnessing the palpable energy from Water Rally, we turned our focus to Montgomery and the Alabama River for Rivers of Alabama Day in April. With more than 40 participants in Montgomery talking directly to their elected officials, the event highlighted the importance of talking to legislators about protecting rivers.

Heading into May, our collaboration moved back to Birmingham, where we worked with both national and local partners to host the first Renew Alabama climate change conference. During the summer, I led a Leadership Development Training for Friends of Turkey Creek Nature Preserve. Ensuring local partners are strong internally is a key service that we offer our Alliance member groups. As fall approached, our work



once again turned to the all-important task of empowering groups and citizens to talk to their elected official about environmental issues. Partnering with Sierra Club and Conservation Alabama, our Volunteer Lobbyist Training workshop helped attendees gain the tools and confidence to approach local and state elected officials about issues of concern. As I look back on the year, I am proud to be a part of this vibrant Alliance, I am grateful for the connections made and look forward to more successes together in 2018!




# FINANCIAL INFORMATION
